# Terms & Conditions

## Liability

- The organizers cannot be held responsible for any loss of damage of/to any equipment brought in for the Exhibitor/Sponsor's exhibition. The Exhibitor/Sponsor is therefore advised to ensure to take out adequate insurance cover as necessary including Employers Liability & Public Liability cover, insurance to cover loss of damage to venue, exhibits or other personal property.
- Booths are not guarded. It is advised not to leave any valuable equipment on the booths.
- The organizers reserve the right to modify the exhibition floor plan at any time.
- If an exhibitor fails to comply with the official rules and regulations, the organizers reserve the right to reclaim its exhibition space and resell it, and all monies paid by the exhibitor shall be forfeited.
- In case of the use of any special, dangerous or radioactive materials, gases etc. the written approval of Medicongress is required.
- In case of litigation the court of Ghent is in charge.

## General

- Political Propaganda is not permitted on booths or in any other part of the exhibition area.
- Radio License: Given the proximity of the event venue to the central station, it is essential to emphasize that obtaining a license is mandatory, as strict regulations are enforced to prevent any potential disruption to train traffic. The license application should be submitted via the BIPT website. Please note that there is a processing time.
- Numbers of participants communicated by the organizers are estimations and not certainties.
- By signing a sponsor and/or exhibitor contract, sponsors and exhibitors accept the conditions stated in this document.

## Congress Cancellation and Postponement

- Exhibitors and sponsors shall not be entitled to any compensation should political or economic circumstances or a case of "force majeure" prevent the exhibition and/or the Congress being held, limit its size or modify its nature.
- In the event that the Congress is postponed for any given reason, the exhibitor/sponsor/advertiser will not be entitled to cancel the exhibition space/sponsorship/advertising

or to obtain monetary compensation, but the benefits that have been agreed will remain in place for the rescheduled event.

- In the event that the Congress is cancelled for any given reason, the organizers will refund the exhibition/sponsorship/advertising money to the relevant company, minus any benefits that have been received by the company prior to the cancellation and any expenses incurred by the organizers with respect to the provision of the agreed benefits.
- Should the Congress format or medium change (to include hybrid or fully virtual event delivery) the exhibitor/sponsor/advertiser will not be entitled to cancel or to obtain monetary compensation, but the benefits that have been agreed will remain in place and adjusted appropriately.

## Payments

- All companies will receive an official invoice from Medicongress.
- All booths and sponsorship must be paid in full within 30 days of invoicing.
- The installation of a booth will only be allowed if payment in full is received by Medicongress. The organizers reserve the right to refuse admission to any person or organization and to order the expulsion of any person or organization whose conduct renders such a course desirable without any further statement of reasons.
- All rates are exclusive of VAT (21%)
- Payment Methods:
  - via wire transfer (BE20 7362 3387 1656).
  - Credit card payments are not possible.
- Flexible Payment Options: Invoices can be split across multiple years (2025 and 2026) for added convenience.

## Exhibition Cancellation Procedure

- Booth spaces that have been contracted can be cancelled within 30 days of signing the contract.
- Within these 30 days, only a written cancellation will be accepted, and a cancellation fee of € 500 will be charged.
- No cancellations are accepted after 31 March 2026, regardless of the reservation date.
- The signed Reservation Contract is binding for all parties.
